The tax claim is a claim under the public law. Principles applicable to relationships under the private law such as the law of contracts, therefore, cannot be invoked to interpret provisions of tax law. No tax shall be levied or collected save by the authority of law, as provided by Article 265 of the Constitution of India.
